Notice under section 708(5)(e) of the Corporations Act

Adelaide, South Australia - this notice is given by Alcidion Group Limited (ASX:ALC) (**Alcidion**) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

Alcidion advises that it has today issued 5,000,000 fully paid ordinary shares (**New Shares**) upon the exercise of unlisted options (**Options**).

The 5 million Options were exercised by former director Mr Brian Leedman at the exercise price of 6 cents. Mr Leedman served as Non-Executive Director of Alcidion for a year from 28 July 2016 to 31 July 2017 after the ASX listing of Alcidion via the reverse takeover of Naracoota Resources. The Options were provided to Mr Leedman on 29 November 2016. The 5 million New Shares issued increases the total number of fully paid ordinary shares outstanding to 810,671,138.

Mr Leedman still has 5 million additional Options outstanding, expiring 30 June 2020, at the exercise price of 8 cents. No other Options are currently outstanding.

In accordance with section 708A(6) of the Corporations Act, Alcidion advises that:

- a) the New Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- b) it is providing this notice under paragraph 5(e) of section 708A of the Corporations Act;
- c) as at the date of this notice Alcidion, as a disclosing entity under the Corporations Act, has complied with:
 - i. the provisions of Chapter 2M of the Corporations Act as they apply to Alcidion; and
 - ii. section 674 of the Corporations Act; and
- d) as at the date of this notice, there is no excluded information of the type referred to in sub-sections 708A(7) and 708A(8) of the Corporations Act.


